READ THE TERMS AND CONDITIONS CAREFULLY BEFORE USING THIS SITE.

INTRODUCTION.- Welcome to the website [www.cheaptransferstours.com](http://www.cheaptransferstours.com), collectively referred to as the 'Site'. Your use of this Site is expressly conditioned upon your acceptance of these Terms and Conditions. By using this site, you signify your consent to the Terms and Conditions. CheapTransfersTours reserves the right to add or modify the Terms and Conditions at any time. All terms added or modified will take effect at the time they are updated. The continuous use of this site even after the publication of the changes made to the Terms and Conditions will mean that you accept these changes. Please return periodically to this page to check any changes.

DEFINITIONS.- For all purposes of the Terms and Conditions hereby established, the following definitions shall be understood: LAND TRANSPORTATION SERVICE.- Company (TRYST SERVICIOS SA DE CV) this last company for the purpose of marketing the services through the Islands of CheapTransfersTours in centers or commercial plazas. Those who hire and / or act as intermediaries through their reservation services, for the benefit of a User-Tourist, regarding the tourist services provided directly by the Provider. (Hereinafter referred to as the 'Site'). USER-TOURIST.- Person who travels temporarily and / or who uses the site [www.cheaptransferstours.com](http://www.cheaptransferstours.com), with the purpose of making use of the intermediation and booking engine of CheapTransfersTours and with the ultimate purpose of enjoying any of the services provided directly by the Provider. (Hereinafter referred to as 'You'). PROVIDER.- Physical or moral person that provides direct tourist services to the User-Tourist, contracted, reserved or acquired by the latter through the intermediation and booking engine of the CheapTransfersTours site.

(e) That for the purposes of these Terms and Conditions, it only acts as INTERMEDIARY between you and the Providers of said tourist services, and that for such purpose, it has the technical and administrative capacity, as well as the necessary material and human elements to reserve on your behalf and at your request the services referred to in these Terms and Conditions. (f) That based on the foregoing statements, you accept these Terms and Conditions.

(b) That it has authorization from the Ministry of Tourism to provide Travel Agency service, likewise it is registered before the Tax Authorities with the Federal Taxpayers Registry number (TSE220210JL2). (c) That his / her address is located at (MAR DE PLATA Num. 27 PUERTO VALLARTA, JALISCO C.P. 48315) (d) That its corporate purpose consists of the faculty to: Serve as an intermediary between tourists and providers of transport services of any kind, in the terms indicated in the Laws and Regulations. Serve as an intermediary between other providers of tourist services (including but not limited to hotels, fun and entertainment centers, excursions, guided tours and / or rental of all types of vehicles) and other travel agencies; -. (E) That for the purposes of these Terms and Conditions, it only acts as an INTERMEDIARY between you and the Providers of said tourist services, and for that purpose, has the technical and administrative capacity, as well as the material and human elements necessary to book by account and at your request the services referred to in these Terms and Conditions. (f) That based on the foregoing statements, you accept these Terms and Conditions.

OBJECT.- The object consists of the INTERMEDIATION that will exist between CheapTransfersTours, You and the Suppliers, where CheapTransfersTours, for the purposes of these Terms and Conditions, will act solely and exclusively as an INTERMEDIARY, providing You through its Website. enunciative but not limitative way, the reservation service of ground transportation, and air; reservation in hotels and lodging establishments; reservation of tourist attraction sites; booking of travel packages; Among others, So, once the reservations are confirmed by CheapTransfersTours containing the tourist services chosen by you (according to their availability), it will be concluded with the provision of the intermediation service by CheapTransfersTours, since these services will be provided to you by the Suppliers directly.

**USE OF THE SITE.-** CheapTransfersTours grants you a limited, non-transferable, revocable license to use this Site in accordance with these Terms and Conditions. ## RESERVATION, PAYMENT AND CANCELLATION POLICIES

**RESERVATION POLICIES.**- The rates shown on the website are only valid at the time of your quote. The rates will apply for their respective charge, only in case of reserving the desired service, otherwise the rates may vary. A reservation is considered complete, when you have a confirmation number and the corresponding charge has been applied. At the time of booking, you authorize us in writing and / or verbally to use your credit card number to make your payment, and expressly confirm to know and accept these Terms and Conditions, as well as the privacy policy of CheapTransfersTours. All reservations are subject to availability at the time of processing your request. Availability can not be guaranteed until full payment has been received. Mexican Pesos will be charged in Mexican Pesos. **CANCELLATION POLICY:-** All requests for cancellation must be informed by you in writing via e-mail to your assigned Travel Advisor, mentioning your reservation number. For Cancellation of Hotel Reservations: At the time of selecting the hotel of your choice, you can consult the links called Cancellation Policy, the terms and conditions of cancellation applicable to each Hotel. For Cancellation of Tours Reservations and / or Land Transportation: At the time of booking, the cancellation policies applicable for the specific tour or ground transportation will be automatically displayed on the screen for your information. Next, CheapTransfersTours describes its general cancellation policies, applicable to most tours and ground transportation services:

- Reservations canceled X days or more before the date of service, are subject to a charge of X% of the total amount of your reservation.
- Reservations canceled from X to 0 days before the date of service, or in case of not arriving, will not be refunded.

- The changes will apply to the service and passengers of the purchase
- Changes are subject to bus availability
- No There are changes of discounted tickets (ie student, teacher)
